Annual Members Meeting

April 1, 2019 at 7:30 pm Good Shepherd Ministries

Directors Present: Doug Dear, Charlie Koehn, Mike McKie, Jim Weatherford, Ken Jowers, John Judd and Paul Kaskie. Cynthia Dear, Admin. Recorded the minutes.

Members Present: All members present signed an attendance sheet, which is attached to these minutes as part of the record.

There being members present representing 23 votes, it was determined that a quorum was present; the President called the meeting to order at 7:30 pm.

- 1. Directors and members introduced themselves.

- 4. Paul Kaskie reported on the gate repairs made. Gate clickers can be purchased on Amazon.

- 5. Improvements of the subdivision roads were reported on by Doug Dear and Paul Kaskie. County improved bar ditches and drainage at south end of Southern Dr. and Elm Grove outside of gate need work. Jim Weatherford will get Jerry with TXDOT's email so we can write a letter to the County Commissioner and TXDOT about our drainage ditch issues. On-going road maintenance was discussed. Annual maintenance road repairs crack sealing is in the HOA 2019 budget. Paul Kaskie to coordinate Lone Star for repairs and crack seal work. The gate code will remain the same and may be given out to your service providers i.e. trash pick-up. There was a discussion regarding Lot 18 having a Bible study and the attendees parking in the ditch and compromising the road and creating safety issues. Doug Dear agreed to speak with the Lot Owner.
- 6. ACC Doug Dear answered questions regarding fence heights and what is allowed in the subdivision.
- 7. Subdivision entrance maintenance plans were discussed. Mike McKie agreed to work on the lights. Doug Dear agreed to work on getting mulch for the planting beds.
- 8. Neighborhood Watch- We all need to be aware and watch for any suspicious activity and report it to the sheriff. Don't hesitate to call 9-1-1.
- 9. It was reported that two deer had been shot with an arrow in our subdivision. The HOA members were made aware that there is no hunting allowed in the subdivision and is against the law.
